5. PROTECTION OF PERSONAL DATA

According to Art. 13 sec. 1 and sec. 2 of the GDPR (Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Regulation on data protection) of April 27, 2016 (Journal of Laws of the EU. L No. 119), hereinafter referred to as the GDPR

5.1 The administrator of personal data is Karolina Romańska

5.2 We have not appointed a DATA PROTECTION OFFICER. The contact point in the subject of the action is: info@nasza-dolina.pl

5.3 Personal data is collected and processed for the following purposes:

- Fulfilling the obligations assumed by the organizer as part of the organized event
- Protection against claims and pursuing claims [taking care of the economic interest and image of the administrator until the expiry of the claims period in accordance with the provisions of the Civil Code
- Publication of the image of participants in any way in which information about the event will be published or disseminated and for marketing purposes of the organizer

5.4 The Administrator may process Participants' personal data for as long as it is necessary to achieve the purposes for which the data was collected, unless there is a technical, legal or other important reason justifying the removal, destruction or anonymization of this data.

5.5 The personal data administrator does not transfer data to a third country/international organization. Personal data of participants will not be subject to automated processing, including profiling.

5.6 The basis for the processing of your personal data is art. 23 sec. 1 point 3 UODO and art. 6 sec. 1 letter b) of the GDPR - performance of the contract (acceptance of the Regulations and application for participation in the event constitutes the conclusion of the contract) and art. 23 sec. 1 point 1 of the GDPR and art. 6 sec. 1 lit. a) GDPR - voluntary, unambiguous, informed and specific consent of the data subject.

5.7 The Participant has the right to access their data and the right to rectify, delete, limit processing, the right to object, and the right to lodge a complaint with the supervisory authority.

5.8 In the event that the participant decides to exercise these rights, we may ask for additional personal data aimed at their unambiguous identification, in order to verify whether it is actually a specific participant who demands the exercise of his rights, and we are not dealing with an incident or abuse. Providing personal data and consenting to their processing is voluntary, but failure to provide them or lack of consent to their processing will result in the impossibility of fulfilling the obligations assumed by the Administrator as part of the organized rally, and thus prevents participation in the event
